RE: Request for County Park Funds for Special Needs

Dear Mr. Burtka:

The Board of Hillsdale County Park Commissioners hereby respectfully requests the County Board's approval to use approximately \$800 of the avigation easement monies that were previously set aside in a separate park fund. The fund was set aside by the County Board to be used for the maintenance, improvement or expansion of the parks or for the purchase of buildings, fixtures or equipment solely for use in the county parks.

The funds requested are needed to replace the badly deteriorated safety float rope at the Bird Lake County Park beach. As several years ago there was a fatal drowning of a 16 year old youth near the Bird Lake beach swimming area, the Park Commission was awarded a Hillsdale County Community Foundation grant so a float rope could be installed to forewarn swimmers of the abrupt drop-off into much deeper water. As an added precaution, the Bird Lake Property Owners Association erected signs giving notice of the designated swimming area inside the float rope. Thus, we are committed to having the float rope and we are required by the terms of the grant to maintain the rope. We are not eligible to apply for another HCCF grant this entire year.

The Park Board feels this is a justifiable expense, outside of our normal operations, that should be eligible for funding from the parks funds set aside for special expenditures such as this.
